

## **Lilith Local Talent Search Best Predictor Giveaway Contest**

**NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.** OPEN ONLY TO OURSTAGE ACCOUNT-HOLDERS WHO ARE 13 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY AND ARE LEGAL RESIDENTS OF THE UNITED STATES AND/OR CANADA. VOID WHERE PROHIBITED BY LAW. THESE OFFICIAL RULES OUTLINE THE LILITH LOCAL TALENT SEARCH BEST PREDICTOR GIVEAWAY CONTEST ("CONTEST").

### **BEST PREDICTOR CONTEST DESCRIPTION:**

Each entrant is asked to honestly and insightfully judge at least the minimum number of battles (as defined in Section 2) within the Lilith Local Talent Search Channels. OurStage.com looks to reward their community for recognizing and discovering new talent. OurStage considers predictors a valuable asset to their community. OurStage intends to rewards predictors on their ability to identify talent that best represents the overall community's pick.

1. **ELIGIBILITY:** Open to OurStage account-holders who have Internet access and are thirteen (13) years of age or older at the time of entry. The following are not eligible: employees, contractors, directors and officers of Sponsor organizations, and each of their respective parent, subsidiaries and affiliated companies, distributors, web design, advertising, fulfillment, judging and Contest agencies involved in the administration, development, fulfillment and execution of this Contest (collectively, "Contest Parties"), and the immediate family members of each (spouse, parent, child, sibling, grandparent, and spouse or "step" of each) and those living in their same households (those persons whether related or not who live in the same residence for at least three months during the twelve-month period preceding the start date of the Contest).
2. **TO ENTER:** There are two ways to enter. One way enter the Contest, is entrant can first create a free account by logging on to [www.ourstage.com](http://www.ourstage.com) ("Web Site"). Once you are on the Home Page, click on the word "Judge" at the top of the page. This will bring you to a page that will allow you to judge in any of the Lilith Local Talent Search Channels. The second way to enter is by logging into OurStage using Facebook Connect and judging in any of the Lilith Local Talent Search Channels from Lilith Fair's main facebook page: [www.facebook.com/lilithfairtour](http://www.facebook.com/lilithfairtour).

To be eligible for the Best Predictor Giveaway entrants must:

- Participate in at least 25 Sort4 and/or 100 Head-To-Head battles. Both Sort4 and Head-to-Head battles are acceptable forms of judging on OurStage.com. Additional information on the forms of judging can be found on the OurStage FAQs, <http://www.ourstage.com/about/faqs>.
  - The entrant must vote within the Lilith Local Talent Search Channel and between the Contest Period. There is no limit on the number of times you can vote.
3. **BEST PREDICTOR GIVEAWAY CONTEST PERIOD:** Best Predictor Giveaway begins once the Contest become available on Web Site for entrants to vote on, but no later than 12:00:00 am ET on May 1, 2010 and ends at 12:01:00 am ET on May 31, 2010 ("Contest Period").

#### 4. **PRIZES:**

One winner for each Lilith 2010 touring market will receive:

- Two (2) tickets to the Lilith 2010 in the market closest to winners hometown.

Winners shall be responsible for all costs, including any travel or transportation costs associated with getting to the Lilith 2010 tour stop.

A total of Thirty-five (35) Contest Grand Prize Winners will be selected for the Lilith Local Talent Search Best Predictor Giveaway Contest.

5. **SELECTION AND NOTIFICATION OF PRIZE WINNERS:** The Contest Grand Prize Winners will be selected on or around June 15, 2010. The winners will be selected based on OurStage's proprietary ranking algorithms that analyzes each entrant's judging patterns in the Lilith Local Talent Search Channels. The ranking algorithm assigns a judging score to each entrant. The entrant with the highest judging score from each of the Lilith Local Talent Search Channels will be selected for the Contest Grand Prize. The ranking algorithm determines the judging score of each entrant by analyzing his/her voting patterns during the Contest Period. The entrant's voting pattern that best reflects the final rank order of the submissions in the Lilith Local Talent Search Channel will be assigned more points in their score. The entrant with the highest cumulative score from each Lilith Local Talent Search Channel will be named the Contest Grand Prize Winner.
